TERMS AND CONDITIONS

Initials

- I/We understand the property tax account must be current prior to the initiation of the Tax Instalment Payment Plan or have a signed Tax Agreement in place.
- I/We understand that the plan runs from January to December of each year and continues each year unless cancelled by written notification. It is the **responsibility of the property owner(s)** to advise the Town of Ponoka 10 business days prior to your payment withdrawal date, of any changes required in that month (ie bank account information, sale of the property or cancellation of monthly payments).
- I/We understand the monthly payment is fixed and estimated off of the previous year's taxes for the months of January through June and from July to December the monthly payment amount will automatically be adjusted in accordance with the establishing of the annual tax rates.
- I/We understand that payments are withdrawn from the bank account provided on the payment withdrawal date or next business day. Any payments that are dishonoured by reason of non-sufficient funds, stop payment, account closure etc will be subject to an NSF fee of \$25.00 and the account will be removed from the plan without prior notice if two payments have been dishonoured. All outstanding amounts then will become due and payable by July 31 and subject to penalties in accordance with our current Property Tax Penalty Bylaw.
- I/We understand that if any transfers to the property tax account have occurred, my monthly payments will be adjusted accordingly without notice.
- I/We understand that the December payment amount may vary if payments have been dishonoured or if any transfers to the property tax account have occurred (ie outstanding utilities transferred). The property tax account must have a zero balance as at December 31.
